SUPERVISOR COMMENTS

Officers were kept busy for a majority of the shift, dealing with calls for service. In the beginning of the shift TPD received a report by a family member that they received a text message from a family member, stating they were being kidnapped and was in danger. After some investigation, the officer was able to locate the member who allegedly sent the

text message. He was fine, and denied sending any such text. Officers also responded to a fight at a local restaurant. Apparently, a drunk male in the bar went to a stranger and started talking with him. He started to touch the subject and then kissed him. The unknown subject pushed him away and the drunk patron attempted to kiss the male again. The unknown male then punched the drunk patron once, knocking him out. The unknown male fled the establishment prior to TPD arrival. Video of the incident was gathered and follow-up will be done to identify the male.

SUPERVISOR COMMENTS

Officers responded to a domestic violence dispute between a couple. Both parties had visible injuries but officers determined the male to be the primary aggressor and was placed under arrest. He as booked into jail. Officers also responded to another domestic violence incident involving a female victim reporting she was strangled and raped by her boyfriend. Both parties did not have any visible injuries and there was no evidence to support this happening. The male denied any physical altercation and admitted they both had consensual sex, and said the female got upset at him when he tried to end the relationship after. The female was taken to the hospital for an exam and the male was served with an emergency protective order for the time being. The report will be forwarded to detectives for additional follow-up. An officer also responded to the hospital for the report of a stabbing victim. the victim was uncooperative and would not provide the officer with details of what occurred. A report was taken with limited information.
